1. Introduction

The *Privacy Act* (Revised Statutes of Canada, Chapter P-21, 1985) was proclaimed on July 1, 1983.

The *Privacy Act* provides Canadian citizens and permanent residents with the right of access to, and correction of, personal information about themselves that is under the control of a government institution. The Act also provides the legal framework for the collection, retention, use, disclosure, disposition and accuracy of personal information in the administration of programs and activities by government institutions subject to the Act.

Section 72 of the *Privacy Act* requires that the head of every government institution prepare for submission to Parliament an annual report on the administration of this Act within the institution during each financial year.

This report represents an overview of the activities of the Natural Sciences and Engineering Research Council of Canada (NSERC) for the reporting period of April 1, 2020 to March 31, 2021 (the current reporting period).

2. About the NSERC

2.1 Mandate

NSERC was established on May 1, 1978, as a federal agency defined as a "separate employer" by the *Public Service Staff Relations Act*. It is funded directly by Parliament and submits reports to it through the Minister of Innovation, Science and Industry, with responsibility for promoting and assisting research in the natural sciences and engineering, other than the health sciences. NSERC is the primary federal agency investing in post-secondary research and training in these disciplines.

NSERC's Council is composed of a President and up to 18 other distinguished members selected from the private and public sectors. NSERC's President is the Chief Executive Officer. The elected Vice-President is the Chair of the Council and of its Executive Committee. NSERC's Council is advised on policy matters by various standing

committees. Funding decisions are made by the President, or designate, on the basis of recommendations made by peer review committees.

2.2 Responsibilities

NSERC helps make Canada a country of discoverers and innovators for the benefit of all Canadians. Over the last 10 years, NSERC has invested more than \$10 billion in basic research, projects involving partnerships between postsecondary institutions and industry, and the training of Canada's next generation of scientists and engineers.

NSERC's five strategic goals are to:

- Foster a science and engineering culture in Canada and make science and engineering mainstream.
- Launch the new generation, mobilize Canada's future brain trust and enable earlycareer scientists to launch independent research careers.
- Build a diversified and competitive research base and stimulate breakthrough research and research excellence.
- Strengthen the dynamic between discovery and innovation, and deepen interactions between colleges and universities, the private sector, governments and civil society.
- Go global, secure Canada's access to global scientific and engineering knowledge and expertise, and increase participation in international research endeavours.

3. Organizational structure and delegation of authority

3.1 The Organizational Structure

The Access to Information and Privacy (ATIP) Office resides in NSERC's Secretariat under the directorship of the Corporate Secretary.

A full-time ATIP Coordinator position reported to the Corporate Secretary and was assisted by an ATIP/Secretariat Officer who spent about half of his/her time on ATIP. The delegation of authority from the President included the Vice-President, Communications, Corporate and International Affairs; the Executive Director, Corporate Planning and Policy; the Corporate Secretary and the ATIP Coordinator.

Additional term employees, temporary help service contractors and students were used for additional resources, as required.

3.2 The ATIP Office

The ATIP Office coordinates responses to requests submitted to NSERC under the *Privacy Act*. It also provides interpretation, advice, and recommendations to NSERC staff on the implications of the *Privacy Act* on their activities, and delivers training, education and awareness sessions to staff. In 2020-2021, ATIP staff provided privacy advice and guidance to NSERC staff on a wide range of programs and activities. ATIP Office activities also include:

- Preparing annual statistics for the Treasury Board of Canada Secretariat (TBS) and an Annual Report to Parliament;
- Updating information on NSERC's web site regarding privacy issues;
- Providing advice and guidance to staff and senior management on privacy issues;
- Documenting and resolving privacy breaches;
- Coordinating updates to the *Info Source* publication:
- Managing the ATIP electronic management system;
- Reviewing departmental documents;
- Providing feedback to Justice Canada on the modernization of the Privacy Act;
 and
- Participating in forums for the ATIP community, such as the TBS ATIP Community meetings and working groups.

3.3 Delegation order

Under section 3 of the *Privacy Act*, the President of the NSERC is designated as the head of the government institution for purposes of the administration of said act.

Pursuant to section 73 of the *Privacy Act*, deputy heads may delegate any of their powers, duties or functions under the *Privacy Act* by signing an order authorizing one or more officers or employees of the institution, who are at the appropriate level, to exercise or perform said powers, duties or functions. This Delegation of Authority can be found in <u>Appendix A</u>.

4. Interpretation of Statistical Report

NSERC's 2020-2021 statistical report on the *Privacy Act* is provided in <u>Appendix B</u>.

4.1 Requests under the Privacy Act

From April 1, 2020 to March 31, 2021, NSERC received 22 new privacy requests: 7 were closed during the reporting period and 23 carried over to 2021-2022. This amount was higher than all preceding reporting periods (in 2019-2020 there were 7 requests).

In addition, 8 requests were carried forward from the 2019-2020 reporting period. 2 of these requests were closed during the 2020-2021 reporting period, while 6 requests remain outstanding. processed

In total, NSERC 464 pages of which 268 were disclosed. NSERC received fewer requests than the 2019-2020 reporting period, but the number of pages processed was significantly higher (46%).

Figure 1: Number of privacy requests carried-over, received, and completed 2016-2021





Figure 2: Number of pages processed and pages disclosed 2016-2021



4.2 Disposition of Requests Completed

Of the 7 privacy requests NSERC completed, 6 were disclosed in part, and in 1 case, no records existed.

4.3 Exemptions Invoked

For the privacy requests where the information was disclosed in part, NSERC invoked 6 exemptions under section 26 (personal information about another individual). 1 exemption was under section 19(1)(a) (refusal to disclose if information was obtained in confidence by an institution/government).

4.4 Extension of Time Limits

For the 7 privacy requests completed, 7 thirty-day extensions of time limits were taken past the initial 30 days. NSERC invoked 6 exemptions under 15(a)(i) meeting the original time limit would unreasonably interfere with the operations of the government institutions. NSERC invoked 1 exemption under 15(a)(ii) consultations are necessary to comply with the request that cannot reasonably be completed within the original time limit.

4.5 Completion Time

For the 7 privacy requests completed, 0 requests (0%) were completed on time (2 requests were completed within the 60-day limit), 1 request was not extended and was completed 33 days past the 30-day time limit, 2 requests were completed outside of legislated timelines, but within the 60-day limit (41 and 50 days total), 4 other requests were extended and completed 7, 10, 175, and 625 days past the 60-day limit.

4.6 Consultations

In 2020-2021, NSERC received 0 privacy consultations from other government institutions. This is less than the 1 privacy consultation received in 2019-2020 where the number of consultation pages reviewed by NSERC totaled 3 pages.

4.7 Impact of COVID-19

From March 16, 2020 to March 31, 2020, NSERC experienced an unprecedented period of operational challenges brought about by the COVID-19 pandemic. During this period, NSERC neither received any new requests for personal information nor did NSERC close any pre-existing files.

NSERC's access to information and privacy team worked from home starting on March 17, 2020. Work on requests for personal information was disrupted by the transition to working remotely. Initially, NSERC access to information and privacy team members did not have remote access to specialized privacy request processing software, and other resources available in the head office. Even when full access to specialized ATIP software was available a few weeks later, the challenges of remote work added to the complexity of processing files. Having only remote access, resulted in NSERC's inability to process paper documents and secret clearance files.

Furthermore, NSERC has not had access to a fully operational mailroom since March 16, 2020. The ATIP unit has neither been able to receive any requests for personal information or consultations submitted by mail or courier, nor has the ATIP unit been able to send any material by mail or courier. NSERC is in the process of procuring E-post/extranet services.

In response, NSERC provided access to information and privacy staff and contractors with remote access to email, specialized privacy request processing software and other electronic tools. The ATIP team met regularly by teleconference or video conference during this period. In addition, an auto-generated message was created for NSERC's access to information and privacy email inbox warning clients of possible delays processing requests due to the COVID-19 pandemic.

5. Monitoring and Related activities

The ATIP Office distributed a weekly status report to senior management pertaining to all privacy requests (information is withheld to protect the identity of requestors).

ATIP Office used the software AccessPro Suite to monitor the time to process privacy requests, actions completed, and the level of effort and complexity of each request.

5.1 Informal Practices and Proactive Disclosure

NSERC encourages informal practices of providing information requested outside the ATIP process, provided that the information released is clearly only that of the requester.

In addition, NSERC proactively discloses peer review feedback to grant and award applicants. In 2020-2021, NSERC proactively disclosed thousands of redacted evaluation reports from volunteer external peer reviewers for over 15,543 grant and award applications to the 2,104 referee reports reviewed (individual can apply to more than one funding opportunity). These reports provide feedback to 12,996 applicants on the assessment of their proposals in relation to the program criteria. They are redacted in the spirit of the *Privacy Act* by program staff who has received training by the ATIP staff.

5.2 Costs

The total salary, goods and professional services cost associated with the Privacy program was \$182,356 (comparable to the 2019-2020 cost of \$109,649). This cost does not include the processing of the proactive disclosure to applicants described in 5.1, above.

5.3 Training

The ATIP Office continued its formal training and development activities in 2020-2021. All staff requiring direct access to Equity, Diversity and Inclusion (EDI) data from applicants and peer reviewers were required to undertake training on handling this sensitive personal information. 71 NSERC employees participated in 6 NSERC EDI training

sessions. 3 Bi-agency NSERC/Social Sciences and Humanities Research Council (SSHRC) sessions were also organized and a total of 20 NSERC employees participated in the EDI training. In total, 91 NSERC employees participated in EDI training in 2020-2021.

5.4 Privacy Breach Response

23 potential privacy breaches were reported to NSERC access to information and privacy. Non-material privacy breaches and incidents were managed in accordance with the Privacy/Security Breach Protocol. The ATIP Office was involved in analyzing, containing, and resolving these breaches and incidents, in collaboration with the offices of primary interest (OPIs) and the Chief Security Officer.

NSERC was not required to report these privacy breaches to the Office of the Privacy Commissioner (OPC) due to the low risk and the type of information involved. Nonetheless, those affected by the breach were formally notified as appropriate. NSERC continuously strives to reduce the number of breaches by improving staff awareness and implementing the necessary controls in systems and processes.

5.5 Policies, Guidelines, Procedures and Initiatives

Personal information collected and used by federal departments and agencies is governed by the *Privacy Act* and related regulations, as well as a suite of policy from TBS. NSERC must comply with a number of policies, directives and guidelines, and our Presidents are accountable. This compliance framework is complex and often very demanding for small agencies. It is also evolving and being updated to reflect the reality of current day privacy concerns in our digital world. During the 2020-2021 reporting period NSERC updated its guidelines and procedures in accordance with a directive implemented by TBS (October 2020) to provide up-to-date guidance when releasing information about a small number of individuals.

5.6 Info Source, Publicly Accessible Information and Inquiry Points

Info Source is a series of publications containing information on the Government of Canada and on the government's data collection activities. Info Source is intended to help the public access government information and to exercise their rights under the Privacy Act and the ATI Act. In 2020-2021, NSERC did not make any changes to its Info Source chapter.

NSERC's web site has an ATIP page that provides background information on the *Privacy Act*, how to make a request and who to contact. It provides links to other sources, including *Info Source*, annual reports, and summaries of completed ATI requests.

5.7 Privacy Impact Assessments

For the current reporting period, NSERC did not complete any privacy impact assessments.

5.8 Disclosure under section 8(2)(m) of the *Privacy Act*

Paragraph 8(2)(m) of the *Privacy Act* concerns cases where, in the opinion of the head of the institution, the public interest in disclosure clearly outweighs any invasion of privacy that could result from the disclosure, or where disclosure would clearly benefit the individual to whom the information relates.

During this reporting period, NSERC did not disclose any information under this section of the *Act*.

5.9 Corrections

Paragraph 12(2)(a) of the *Privacy Act* gives individuals a right to request a correction of personal information about them held by the federal government.

3 requests for corrections were carried over from 2018-2019 while 3 additional requests for record correction were received in 2020-2021. 3 requests remain outstanding while 3 requests were closed. These requests were all from 1 individual.

5.10 Challenges

5.10.1 Backlog of Cases

In 2020-2021, NSERC had a carry-over from the previous fiscal year of 8 files. 24 files were carried forward into the 2021-2022 fiscal year. In 2020-2021, NSERC closed 5 of the 22 new requests received. A total of 5 files from 2018-2019, 1 file from 2019-2020, and 18 files from 2020-2021 were carried forward into 2021-2022.

NSERC has limited ATIP resources and was required to establish operational priorities and to claim appropriate extensions of time. Also, NSERC offers to assist requestors in refining their request when it results in a high volume of records that will require consultations, and detailed and complex redactions.

5.10.2 Human Resources

The associated human resources specifically for the administration of the *Privacy Act* and related activities, for this reporting period, is estimated at 1.505 FTE, which is a 33.6% increase over the 1.0 FTE reported for the last reporting period (April 1, 2019 to March 31, 2020). The 1.505 FTE consists of 0.845 full time employee, 0.03 part-time and casual employee and 0.63 consultants and agency personnel.

During the current reporting period, NSERC continued to have some difficulties in staffing. While NSERC allocated the necessary financial resources, it was not able to find a suitable candidate to staff the ATIP Coordinator position on a permanent basis. NSERC recruited a new ATIP/Governance Manager, and began the staffing process to recruit internally a new ATIP officer. The successful internal candidate will then be trained in ATIP, in addition to other duties.

6. Complaints and Audits

6.1 Complaints

Applicants have the right to register a complaint with the *Office of the Privacy Commissioner* (OPC) regarding the processing of a request.

NSERC carried over 6 privacy complaints from the 2019-2020 fiscal year. 0 privacy complaints were received in the 2020-2021 fiscal year. Out of the 6 privacy complaints, NSERC closed 5 of the complaints in 2020-2021. 1 privacy complaint was carried over into the 2021-2022 fiscal year.

6.2 Audits

0 privacy audits were conducted during the reporting period.

6.3 Application/Appeals to the Federal Court or Federal Court of Appeal

There were 0 applications or appeals to the Federal Court or Federal Court of Appeal under the *Privacy Act* during the 2020-2021 reporting period.
